An Act to Expand the Applicability of Certain Energy Standards. Presented by Sen. Bustin of Kennebec; Co-sponsored by Rep. Paradis of Augusta, and Rep. Daggett of Augusta. Energy & Natural Resources Hearing 02/27/91. OTP-AM Accepted 04/08/91. Amended by: CA S-34. Died on Adjournment 07/10/92. Pursuant to Joint Order SP 783, this Bill was Recalled from the Legislative Files. Enacted. Vetoed 01/07/92. Final Disposition: Veto Sustained 01/07/92.
