An Act Allowing Local Governments to Accept Federal and State Funds. Presented by Sen. Pray of Penobscot; Co-sponsored by Rep. Gould of Greenville. State & Local Government Hearing 03/11/91. OTP-AM Accepted 04/22/91. Amended by: CA S-63, SA/CA S-74. Senate - Insisted on Engrossment. House - Adhered to Indefinitely Postponement. Final Disposition: Died Between Houses 04/30/91.
