LD 366 / SP0154

An Act to Appropriate Funds for a Study of the Effectiveness of Education Reform in Maine. Presented by Sen. Bost of Penobscot; Co-sponsored by Sen. Estes of York, Rep. Crowley of Stockton Springs, and Rep. Handy of Lewiston. Education Hearing 03/04/91. OTP-AM Accepted 06/06/91. Amended by: CA S-286, SA/CA S-470. Died on Adjournment July 10, 1991. Pursuant to Joint Order SP 783, this Bill was Recalled from the Legislative Files. Senate - Emergency Enacted; House - Adhered to Failed Emergency Enactment. Final Disposition: Died Between Houses 07/18/91.
