An Act to Provide Funds to the Maine Rural Water Association for Services to Water and Wastewater Systems. Presented by Rep. Mayo of Thomaston; Co-sponsored by Rep. Martin of Van Buren, Sen. Holloway of Lincoln, and Rep. Martin of Eagle Lake. Utilities Hearing 03/11/91. OTP Accepted 03/21/91. Amended by: SA S-434. Died on Adjournment 07/10/1991. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Final Disposition: Emergency Enacted, Approved 07/30/91, P & S LAWS, Chapter 67.
