LD 498 / SP0189

An Act to Modify Weight Limits for Farm Trucks. Presented by Sen. Theriault of Aroostook; Co-sponsored by Rep. Martin of Van Buren, Rep. Pines of Limestone, and Sen. Collins of Aroostook. Transportation Hearing 03/12/91. Majority OTP-AM Accepted in House; Minority ONTP Accepted in Senate. House - Engrossed as amended by CA S-525; Senate - Adhered to ONTP. Final Disposition: Died Between Houses 02/19/92.
