An Act Requiring the Provision of Information to Victims of Gross Sexual Assault. Presented by Rep. Townsend of Eastport; Co-sponsored by Sen. Vose of Washington. Judiciary Hearing 03/28/91. Majority OTP-AM Accepted 03/04/92 (Minority ONTP). Amended by: CA H-963. Enacted. Pursuant to Joint Order SP 955, this Bill was Recalled from the Governor's desk. Amended by: CA H-963, SA/CA S-692. Final Disposition: Enacted, Approved 04/06/92, PUBLIC LAWS, Chapter 803.
