An Act Relating to Assumption of Medical Expenses by the State in Child Protection Investigations. Presented by Sen. Gauvreau of Androscoggin; Co-sponsored by Rep. Manning of Portland, and Rep. Carroll of Gray. Human Resources Hearing 03/20/91. OTP-AM Accepted 04/25/91. Amended by: CA S-81, SA/CA S-429. This Bill Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from Legislative Files. Final Disposition: Enacted, Unsigned 12/31/91, PUBLIC LAWS, Chapter 623.
