Energy & Natural Resources Hearing 03/15/91. OTP-AM Accepted 05/13/91. Amended by: CA H-257. Emergency Enacted, Pursuant to Joint Order HP 1350, this Bill was Recalled from the Governor's Desk. Amended by: CA H-257, HA/CA H-612. Final Disposition: Emergency Enacted, Approved 06/24/91, PUBLIC LAWS, Chapter 500.
