Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$50,000,000 for Land for Maine's Future. New Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$5,000,000 for Land for Maine's Future Program to Finance the Acquisition of Land for Conservation, Outdoor Recreation, Habitat Conservation and Public Access. Presented by Rep. Mitchell of Freeport; Co-sponsored by Sen. Clark of Cumberland, Rep. Nutting of Leeds, and Rep. Constantine of Bar Harbor. Appropriations & Financial Affairs. OTP-AM Accepted 06/11/91. Amended by: CA (Changed Title) H-600. Enacted, Approved 07/05/91, P & S LAWS, Chapter 44. Final Disposition: Failed in Referendum 11/05/91 (In favor: 161,456; Opposed: 214,929).
