An Act to Reduce Duplication at the Department of Human Services. Presented by Sen. Pray of Penobscot; Co-sponsored by Sen. Bustin of Kennebec, Rep. Manning of Portland, and Rep. Daggett of Augusta. Human Resources Hearing 03/11/91. OTP-AM Accepted 04/30/91. Amended by: CA S-103, SA S-430. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Enacted. Vetoed 01/07/92. Final Disposition: Veto Sustained 01/07/92.
