LD 802 / HP0559

Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$35,000,000 for Construction, Planning, Purchasing and Renovation of Correctional Facilities. New Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$5,500,000 for Construction, Purchasing and Renovation of Correctional Facilities. Presented by Rep. Mayo of Thomaston; Co-sponsored by Rep. Anthony of South Portland, Rep. Gwadosky of Fairfield, and Rep. McKeen of Windham. Appropriations & Financial Affairs. Majority OTP-AM Accepted 06/11/91 (Minority ONTP). Amended by: CA (Changed Title) H-611. Enacted, Approved 07/05/91, P & S LAWS, Chapter 48. Final Disposition: Failed in Referendum 11/05/91 (In favor: 132,898; Opposed: 242,760).
