Brawn of Knox, Rep. Crowley of Stockton Springs, and Rep. Ault of Wayne. Education Hearing 03/29/91. OTP-AM Accepted 06/11/91. Amended by: CA H-615, SB/CA (Changed Title) S-447. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Enacted. Vetoed 01/07/92. Final Disposition: Veto Sustained 01/07/92.
