Gill of Cumberland. Utilities Hearing 04/17/91. OTP-AM Accepted 05/23/91. Amended by CA S-174. Recommitted to Appropriation & Financial Affairs. Died on Adjournment 07/10/91. Pursuant to Joint Order SP782, this Bill was Recalled from the Legislative Files. Recommitted to Appropriations & Financial Affairs. Appropriations & Financial Affairs Re-referred to Human Resources.
