LD 882 / SP0326

An Act to Amend the Laws Concerning Certification of Educational Personnel. Presented by Sen. Estes of York; Co-sponsored by Rep. Crowley of Stockton Springs, Rep. Norton of Winthrop, and Rep. Cahill of Mattawamkeag. Education Hearing 04/01/91. OTP-AM Accepted 06/06/91. Amended by: CA S-253, SA/CA S-431. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Emergency Enacted. Vetoed 01/07/92. Final Disposition: Veto Sustained 01/07/92.
