LD 926 / HP0652

An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, Highway Fund, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 1992 and June 30, 1993. Presented by Rep. Strout of Corinth; Co-sponsored by Sen. Gould of Waldo, Rep. Macomber of South Portland, and Sen. Theriault of Aroostook. Transportation Hearing 04/23/91. Recommitted to Transportation. Majority OTP-AM Accepted 07/01/91 (Minority OTP-AM). House - Adhered to Emergency Enactment; Senate - Adhered to Failed Emergency Enactment. Died Between Houses. Pursuant to Joint Order HP 1383, this Bill was Recalled from the Legislative Files. Amended by: CB H-735, HA/CB H-751. Final Disposition: Emergency Enacted, Approved 07/08/91, PUBLIC LAWS, Chapter 529.
