Resolve, Authorizing a Payment to Steven P. Smith and Ramona Smith of \$47,908.06. Presented by Sen. Twitchell of Oxford. Legal Affairs Hearing 04/11/91. Majority OTP-AM Accepted 05/13/91 (Minority ONTP). Amended by: CA S-137. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 781, this Bill was Recalled from the Legislative Files. Final Disposition: Finally Passed, Unsigned 12/31/91, RESOLVE LAWS, Chapter 54.
