Presented by Sen. Brawn of Knox; Co-sponsored by Rep. Carroll of Southwest Harbor, and Rep. Skoglund of St. George. Marine Resources Hearing 04/23/91. OTP-AM Accepted 06/10/91. Amended by CA S-290, SB/CA S-441. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files.
