An Act to Amend and Improve the Laws Relating to Education. Presented by Sen. Brawn of Knox; Co-sponsored by Rep. Barth, Jr. of Bethel, and Rep. O'Gara of Westbrook. Education Hearing 04/10/91. OTP-AM Accepted 05/20/91. Amended by: CA S-153. Indefinitely Postponed. Pursuant to Joint Order HP 1647, this Bill was Recalled from the Legislative Files 02/20/92. Amended by: HB H-918, SA S-552. Final Disposition: Emergency Enacted, Approved 03/13/92, PUBLIC LAWS, Chapter 655.
