Resolve, to Provide Additional Funding and an Extension of Time to Allow Phase 2 of the New Capitol Area Master Plan to Be Completed. (Reported Pursuant to Resolve 1989, chapter 60). State & Local Government Hearing 04/24/91. Majority OTP-AM Accepted 06/10/91 (Minority ONTP). Amended by: CA S-239. Recommitted to Appropriations & Financial Affairs. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 782, this Bill was Recalled from the Legislative Files. Recommitted to Appropriations & Financial Affairs. Final Disposition: ONTP Accepted 01/16/92.
