LD 1377 / SP0516

An Act to Create a State Municipalities Investment Pool. Presented by Sen. Pray of Penobscot; Co-sponsored by Rep. Gwadosky of Fairfield, Sen. Bustin of Kennebec, and Rep. Goodridge of Cornville. State & Local Government Hearing 04/29/91. Recommended to State & Local Government. Minority ONTP Accepted in House; Majority OTP-AM Accepted in Senate. Senate - Failed Engrossment. Final Disposition: Died Between Houses 03/03/92.
