Matthews of Kennebec. Fisheries & Wildlife Hearing 04/18/91. OTP-AM Accepted 05/20/91. Amended by: CA S-146. Recommended to Appropriations & Financial Affairs. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 782, this Bill was Recalled from the Legislative Files. Recommended to Appropriations & Financial Affairs. Re-referred to Fisheries & Wildlife. OTP-AM Accepted 02/11/92. Amended by: CB S-533. Final Disposition: Enacted, Approved 03/03/92, PUBLIC LAWS, Chapter 642.
