New Title: Resolve, Relating to Medicaid Rules Governing Services to Persons with Mental Retardation. Presented by Sen. Pray of Penobscot; Co-sponsored by Sen. Bustin of Kennebec, and Rep. Goodridge of Pittsfield. Human Resources Hearing 04/22/91. OTP-AM Accepted 06/05/91. Amended by: CA (Changed Title) S-231, SA/CA S-437. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Final Disposition: Emergency Finally Passed, Approved 07/30/91, RESOLVE LAWS, Chapter 51.
