LD 1512 / HP1039

An Act to Compensate Landowners for Land Value Lost because of Wildlife Restrictions. Presented by Rep. Skoglund of St. George. House - Adhered to Reference to Energy & Natural Resources. Senate - Adhered to Reference to Taxation. Died Between Houses. Pursuant to Joint Order HP 1236, this Bill was Recalled from the Legislative Files. Taxation. Final Disposition: ONTP Accepted 06/05/91.

Joint Order, Recalling Bill "An Act to Compensate Landowners for Land Value Lost because of Wildlife Restrictions," HP 1039, LD 1512, from the legislative files to the House. Presented by Representative SKOGLUND of St. George. Final Disposition: Passed in Concurrence 05/07/91.
