An Act to Extend the Certificate of Need Program to All Major Medical Equipment. Presented by Rep. Manning of Portland; Co-sponsored by Sen. Conley of Cumberland, and Sen. Gill of Cumberland. Human Resources Hearing 05/01/91. Majority OTP-AM Accepted 05/28/91 (Minority ONTP). Amended by: CA H-349, HA H-431. Enacted. Final Disposition: Veto Sustained 06/28/91.
