An Act to Regulate Sales of Malt Liquor in Kegs. Presented by Rep. Kilkelly of Wiscasset; Co-sponsored by Rep. Gray of Sedgwick, Rep. Pineau of Jay, and Sen. Holloway of Lincoln. Legal Affairs Hearing 05/08/91. OTP-AM Accepted 06/06/91. Amended by CA H-490, HA/CA H-621. Enacted. Pursuant to Joint Order HP 1366, this Bill was Recalled from the Governor's Desk.
