An Act to Establish a Public Solid Waste Facilities Loan and Grant Program. Presented by Sen. Foster of Hancock; Co-sponsored by Sen. Ludwig of Aroostook, Rep. Jacques of Waterville, and Rep. Michaud of East Millinocket. Energy & Natural Resources Hearing 05/06/91. OTP-AM Accepted 06/06/91. Amended by: CA S-277, SA S-303. Recommitted to Appropriations & Financial Affairs. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 782, this Bill was Recalled from the Legislative Files. Recommitted to Appropriations & Financial Affairs. Final Disposition: ONTP Accepted 03/16/92.
