An Act to Amend the Maine Uniform Accounting and Auditing Practices Act for Community Agencies. Presented by Rep. Mitchell of Vassalboro; Co-sponsored by Sen. Bustin of Kennebec. State & Local Government Hearing 05/13/91. OTP-AM Accepted 06/06/91. Amended by: CA H-498. Enacted. Pursuant to Joint Order HP 1359, this Bill was Recalled from the Governor's Desk. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 783, this Bill was Recalled from the Legislative Files. Amended by: CA H-498, SB/CA S-452. Final Disposition: Enacted, Approved 07/30/91, PUBLIC LAWS, Chapter 611.
