LD 1715 / HP1174

An Act to Establish State Selective Purchasing Standards. Presented by Rep. Adams of Portland; Co-sponsored by Sen. Pearson of Penobscot. State & Local Government Hearing 05/13/91. Minority OTP-AM Accepted 06/11/91 (Majority ONTP). Amended by: SC S-423. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Enacted. Vetoed 01/07/92. Final Disposition: Veto Sustained 01/07/92.
