OTP-AM Accepted 06/06/91. Recommitted to State & Local Government. House - Adhered to Engrossed as Amended by Conference Committee A H-703; Senate - Insisted on Rejecting Conference Committee Report. Final Disposition: Died Between Houses 06/30/91.
