An Act to Encourage Business Investments. Presented by Rep. Cashman of Old Town; Co-sponsored by Rep. Kilkelly of Wiscasset, Rep. Melendy of Rockland, and Sen. Brannigan of Cumberland. Housing & Economic Development Hearing 05/02/91. OTP-AM Accepted 06/11/91. Amended by CA H-603. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 783, this Bill was Recalled from the Legislative Files. Amended by: CA H-603, SB/CA S-445. Final Disposition: Emergency Enacted, Approved 07/30/91, PUBLIC LAWS, Chapter 606.
