LD 1775 / HP1217

An Act to Prescribe the Duties and Liabilities of Ice-skating Rink Operators and Persons Who Use Ice-skating Rinks. Presented by Rep. Tracy of Rome; Co-sponsored by Rep. Graham of Houlton, Rep. Sheltra of Biddeford, and Sen. Baldacci of Penobscot. Engrossed Without Reference. Amended by: HA H-285. Enacted. Pursuant to Joint Order HP 1323, this Bill was Recalled from the Governor's Desk. Amended by HA H-285, HB H-526. Recommitted to Business Legislation. OTP-AM Accepted 02/04/92. Amended by: CA H-874. Final Disposition: Enacted, Approved 03/09/92, PUBLIC LAWS, Chapter 648.
