LD 1794 / HP1230

An Act to Amend the Minimum Requirements for Emergency Medical Technicians. Presented by Rep. Vigue of Winslow; Co-sponsored by Rep. Carroll of Gray, and Rep. Farnum of South Berwick. Business Legislation Hearing 05/13/91. OTP-AM Accepted 06/06/91. Amended by: CA H-512. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 783, this Bill was Recalled from the Legislative Files. CA H-512 Indefinitely Postponed. Final Disposition: Engrossed, Enacted, Approved 07/30/91, PUBLIC LAWS, Chapter 613.
