RESOLUTION, Proposing an Amendment to the Constitution of Maine to Provide Greater Legislative Oversight over Agency Rulemaking. Presented by Rep. Gray of Sedgwick; Co-sponsored by Rep. Gwadosky of Fairfield, Sen. Clark of Cumberland, and Rep. Lord of Waterboro. State & Local Government Hearing 05/12/91. Majority OTP-AM Accepted in House; Minority ONTP Accepted in Senate. Committee of Conference Report: Unable to Agree. Final Disposition: Died Between Houses 06/26/91.
