LD 1876 / SP0705

An Act to Authorize a General Fund Bond Issue in the Amount of \$5,000,000 for Major Improvements and Renovations at State Park Facilities and the Restoration and Preservation of Historic Buildings. Presented by Sen. Foster of Hancock; Co-sponsored by Sen. Gould of Waldo, and Rep. Mayo of Thomaston. Appropriations & Financial Affairs. OTP-AM Accepted 06/10/91. Amended by: CA S-325. Enacted, Approved 07/05/91, P & S LAWS, Chapter 49. Final Disposition: Failed in Referendum 11/05/91 (In favor: 122,721; Opposed: 253,267).
