Amended by: CA H-557. Recommitted to Appropriations & Financial Affairs. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 782, this Bill was Recalled from the Legislative Files. Recommitted to Appropriations & Financial Affairs. Re-referred to Business Legislation. OTP-AM Accepted 02/25/92. Amended by: CB H-931. Final Disposition: Indefinitely Postponed 03/31/92.
