An Act to Promote Long-term Economic Development. Presented by Rep. Coles of Harpswell; Co-sponsored by Sen. Pray of Penobscot, Rep. Martin of Eagle Lake, and Rep. Melendy of Rockland. Housing & Economic Development Hearing 05/31/91. OTP-AM Accepted 06/12/91. Amended by: CA H-657. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Amended by: CA H-657, SA/CA S-433. Final Disposition: Emergency Enacted, Approved 07/30/91, P & S LAWS, Chapter 68.
