**History and Final Disposition**

LD 1963 / SP0767

An Act to Implement Constitutional Provisions Restricting the Imposition of Unfunded State Mandates. Presented by Sen. Clark of Cumberland; Co-sponsored by Sen. Cleveland of Androscoggin, and Rep. Gwadosky of Fairfield. State & Local Government. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 782, this Bill was Recalled from the Legislative Files. Recommitted to State & Local Government. Hearing 01/27/92. Final Disposition: Indefinitely Postponed 03/28/92.
