LD 1964 / HP1377

Resolve, to Establish the Commission on Recall. Presented by Rep. Lemke of Westbrook; Co-sponsored by Sen. Conley of Cumberland, Rep. Paradis of Frenchville, and Sen. Gauvreau of Androscoggin. State & Local Government. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 782, this Bill was Recalled from Legislative Files. Recommitted to State & Local Government. Hearing 01/21/92. Majority OTP-AM Accepted 02/11/92 (Minority ONTP). Amended by: CA H-868. Final Disposition: Indefinitely Postponed 03/31/92.
