LD 1966 / HP1378

RESOLUTION, Proposing an Amendment to the Constitution of Maine to Limit the Expenditure of the Funds of a Public Mutual Insurance Company Created by the State to Provide Workers' Compensation Insurance to Employers in this State. Presented by Rep. Mitchell of Vassalboro. Banking & Insurance. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 782, this Bill was Recalled from the Legislative Files. Recommitted to Banking & Insurance. Hearing 01/08/92. Final Disposition: ONTP Accepted 01/28/92.
