History and Final Disposition

LD 1976 / HP1387

An Act to Make Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 1991, June 30, 1992 and June 30, 1993. Presented by Rep. Chonko of Topsham. Engrossed Without Reference. Emergency Enactment Failed. Pursuant to Joint Order HP 1392, this Bill was Recalled from the Legislative Files. House - Indefinitely Postponed; Senate - Emergency Enactment Failed. Final Disposition: Died Between Houses 07/11/91.
