HP1401

Joint Order, That the Joint Standing Committee on Appropriations and Financial Affairs report out a bill to the House to make certain emergency appropriations, deappropriations, allocations and deallocations and to change certain provisions of law necessary to revise the budget for fiscal years 1991-92 and 1992-93 and that the committee report out a bill to the Senate to revise the laws governing general purpose aid to education for fiscal year 1991-92. Presented by Representative CHONKO of Topsham. Final Disposition: Passed in Concurrence 12/18/91. (See LD 1985, LD 1986)
