Original Title: An Act to Restore Maine State Retirement Service Credit to Certain Part-time, Seasonal, Intermittent or Legislative Employees. New Title: An Act Related to the Maine State Retirement System. Presented by Sen. McCormick of Kennebec; Co-sponsored by Rep. Jalbert of Lisbon, Sen. Clark of Cumberland, and Rep. Wentworth of Arundel. Aging, Retirement & Veterans Hearing 02/04/92. ONTP Accepted 02/18/92. Pursuant to Joint Order SP 926, this Bill was Recalled from the Legislative Files. Recommitted to Aging, Retirement & Veterans. Minority OTP-AM Accepted 03/26/92 (Majority ONTP). Amended by: HA (Changed Title) H-1292. Final Disposition: Enacted, Approved 04/09/92, PUBLIC LAWS, Chapter 878.
