Banking & Insurance Hearing 01/22/92. OTP-AM Accepted 02/13/92. Amended by: CA H-895, SB/CA S607. Enacted. Pursuant to Joint Order SP 944, this Bill was Recalled from the Governor's Desk. Amended by: CA H-895, SC/CA S-618. Final Disposition: Enacted, Approved 03/27/92, PUBLIC LAWS, Chapter 755.
