Joint Order, Recalling Bill, "An Act to Strengthen the Public Disclosure of Lobbying Activities," HP 1591, LD 2245, from the legislative files to the House. Presented by Representative GRAY of Sedgwick. In House: Passed; Insisted. In Senate: Failed Passage; Motion to Recede and Concur Failed. Final Disposition: Died Between Houses 03/31/92.
