RESOLUTION, Proposing an Amendment to the Constitution of Maine to Reduce the Size of the House of Representatives. (Submitted by the Special Commission on Governmental Restructuring pursuant to Public Law 1991, chapter 139). State & Local Government Hearing 02/18/92. Minority OTP-AM Accepted 03/15/92 (Majority ONTP). Amended by: CA H-1173 & HB H-1175 in House; Amended by: CA H-1173 & SA S-702 in Senate. Committee of Conference Report Rejected - Unable to Agree. Second Committee of Conference Report Accepted - Unable to Agree. Final Disposition: Died Between Houses 03/31/92.
