HP1636

Joint Order, That the Joint Standing Committee on Appropriations and Financial Affairs report out a bill, "An Act Making Supplemental Appropriations for Fiscal Year 1991-92," and that when said committee reports out "An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State Government for the Fiscal Years ending June 30, 1992 and June 30, 1993 and to Change Certain Provisions of the Laws," HP 1547, LD 2185, that said bill contain no further supplemental appropriations for fiscal year 1991-92. Presented by Representative MAYO of Thomaston. Final Disposition: Passed in Concurrence 02/11/92. (See LD 2379)
