An Act Prohibiting Political Activity by Members of the Workers' Compensation Board. Presented by Senator PEARSON of Penobscot. Referred to Joint Standing Committee on State and Local Government. Public Hearing 01/27/93. Majority OTP-AM Accepted 03/29/93 (Minority ONTP). Amended by: CA S-37, HB/CA H-130. Enacted, 05/10/93. Final Disposition: Veto Sustained 05/10/93.
