Referred to Joint Standing Committee on State and Local Government. Public Hearing 02/17/93. Majority OTP-AM Accepted 04/13/93 (Minority ONTP). Amended by: CA S-55. Enacted, 05/10/93. Final Disposition: Veto Sustained 05/10/93.
