An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State Government and to Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 1994 and June 30, 1995. (GOVERNOR'S BILL). Presented by Representative FOSS of Yarmouth; Cosponsored by Representative: CHONKO of Topsham, Senators: FOSTER of Hancock, PEARSON of Penobscot. Referred to Joint Standing Committee on Appropriations and Financial Affairs. No Public Hearing. Majority OTP-AM Accepted 06/30/93 (Minority ONTP). Amended by: CA H-698, HC/CA H-703. Final Disposition: Emergency Enacted, Signed 07/01/93, PUBLIC LAWS, Chapter 415.
