An Act to Impose Term Limitations on Legislators, Constitutional Officers and the State Auditor. (Transmitted to the Clerk of the House of the 116th Maine Legislature by the Secretary of State 02/12/93.) Referred to Joint Standing Committee on State and Local Government. No Public Hearing. Accepted ONTP 05/13/93. Recalled from Legislative Files 07/01/93. House: Adhere to Indef. Postponement 07/01/93; Senate: Adhere to Passage 07/01/93. Died Between Houses 07/01/93. Final Disposition: Approved in Referendum 11/02/93 (In favor: 159,785; Opposed: 76,732), INITIATED BILL, Chapter 1.

Joint Order, Recalling LD 751 from the Legislative Files to the Senate. Presented by Senator ESTY of Cumberland. In Senate: Passed; Adhered. In House: Indefinitely Postponed; Adhered. Final Disposition: Died Between Houses 07/01/93.
